Our Company was incorporated as a Public Limited Company under the name “**Omega Ag Seeds Punjab Limited**” on November 24, 1992, in accordance with the provisions of the Companies Act, 1956 by the Registrar of Companies, Punjab, H. P. & Chandigarh. The Company was subsequently listed on **BSE Limited** on September 29, 1994.

Our Company is engaged in the business of trading in all kinds of seeds, whether edible or non-edible, including oilseeds, pulses, grains, cereals, vegetables, fruits, crops, fodder, saplings, seedlings, plants, nursery products and oils of all kinds, and other agricultural and allied produce grown or capable of being grown on land or soil, whether natural or cultivated.

The Company had not undertaken significant business operations during the previous financial years. However, during the last two quarters, the Company has commenced limited business activities in its existing line of business. Further, the Company now intends to actively recommence, strengthen, and expand its operations in the aforesaid business segment going forward.

Our Company sources seeds and other agricultural produce from farmers, suppliers and distributors. The experience and guidance of our Promoter and management have been instrumental in establishing operational efficiencies, expanding market reach and strengthening stakeholder relationships. Their expertise in procurement and strategic planning is expected to drive the renewed growth and sustainability of the business.

- 1. We have experienced negative cash flow in recent fiscals and any continued negative cash flows could adversely impact our business, financial condition and results of operations.***

We have reported negative cash flows in recent fiscals. The detailed break up of cash flows is summarized in below mentioned table:

There can be no assurance that our net cash flows shall be positive in the future. Any negative cash flows in the future over extended periods, or significant negative cash flows in the short term, could materially impact our ability to operate our business and implement our growth plans. As a result, our cash flows, business, future financial performance and results of operations could be materially and adversely affected.

- 2. The Company has not generated any operating revenue during the preceding financial years and up to September 30, 2025. Failure to generate revenue in future may adversely impact its financial condition and operations.***

The Company has not recorded any revenue from operations during the preceding financial years till the quarter ended September 30, 2025. The inability to generate revenue indicates that the Company is currently dependent on alternative sources of funding to meet its operational and administrative expenses. The absence of operating revenue over an extended period may indicate challenges associated with establishing and scaling business operations. Subsequent to September 30, 2025, the Company commenced revenue-generating activities and recorded revenue from operations during the third and fourth quarters of Fiscal 2026. However, such revenue generation is at an early stage and there can be no assurance that the Company will be able to maintain, grow or generate sustainable revenue from its operations in future periods.

If the Company is unable to achieve and sustain adequate levels of revenue from operations, it may materially and adversely affect its business operations, cash flows, financial condition, results of operations, and its ability to continue as a going concern.

**3. *Increase in the seeds prices, disruptions in seeds availability, seasonal fluctuations or a decline in demand for seeds may adversely affect our business operations, profitability and financial performance.***

The Company has recently commenced trading of seeds, and its seed trading business is dependent on the availability and pricing of seeds from suppliers. Any significant increase in seed prices, supply, disruption in procurement channels, adverse climatic condition affecting seed production or inability to source seeds on commercially acceptable terms, seasonal variations may adversely impact the Company's ability to fulfil customer orders. Further, increased procurement costs may not always be passed on to customers, which could result in reduced profit margins.

The seed business is inherently seasonal in nature, with demand generally linked to crop cycles, sowing seasons and monsoon patterns. Any delay, deficiency or irregularity in rainfall, changes in cropping patterns, natural calamities, pest infestations, or unfavourable weather conditions may reduce sowing activities and consequently lower demand for seeds. As a result, the Company's sales volumes and revenues may fluctuate significantly from one period to another.

Demand for seeds is also influenced by various external factors such as crop prices, agricultural output, farmer income levels, government support policies, weather conditions, seasonal fluctuations and availability of credit to farmers etc. Any adverse developments in these factors, including a decline in agricultural activity, may reduce demand for seeds and negatively impact the Company's business operations, profitability, and overall financial performance.

If the company is unable to procure seeds at competitive prices, ensure adequate availability of products, effectively manage seasonal fluctuations, or sustain demand for its seed trading business, its business operations, profitability, cash flows and overall financial performance may be materially and adversely affected.

**4. *Improper handling of our products, as well as any spoilage, damage or real/perceived contamination during transit of goods, could expose us to regulatory action, harm our reputation, and adversely impact our business, results of operations and financial condition.***

The Company currently operates on a trading model wherein seeds are procured from suppliers and directly dispatched to customers without being routed through the Company's registered office or any storage facilities owned, leased or controlled by it, thereby exposing it to transit-related risks.

Seeds are sensitive to environmental conditions such as temperature, humidity, and handling practices. Any improper handling, delays, or adverse transit conditions may result in deterioration of quality, spoilage, infestation, contamination or damage or loss of products. Such incidents may lead to rejection of goods by customers, claims, or loss of business.

Further, the Company has limited control over logistics service providers and transportation conditions. Any failure or negligence on the part of transporters, including delays, mishandling, pilferage, theft or accidents, may adversely affect timely delivery and product quality, thereby impacting customer relationships and reputation. Any of the above factors may adversely affect the Company's business operations, customer base, profitability, and overall financial condition.

**5. *Any inability to arrange adequate working capital may adversely affect our business, financial condition, results of operations, and cash flows.***

The Issue proceeds is proposed to be utilized towards meeting our working capital requirements, which are based on certain management assumptions and internal estimates. For further details regarding these estimates and assumptions, please refer to the section titled "**Objects of the Issue**" beginning on page 37 of this Draft Letter of Offer.

The actual working capital requirements of our Company may vary significantly from such estimates due to various factors, including external circumstances, other financial condition or business strategies, changes in business volumes, economic and market conditions, revisions in payment terms with customers and suppliers, or unforeseen expenses. Any such variations may require additional funding to sustain our operations and growth.

To meet any shortfall in working capital, we may be required to raise additional funds through borrowings or other means. Incurrence of additional debt may increase our finance costs and repayment obligations and could subject us to restrictive covenants, thereby affecting our liquidity and operational flexibility. Conversely, if we are unable to secure such additional financing on favorable terms, or at all, our ability to execute projects, maintain inventory, or meet our operational and financial commitments may be adversely impacted.

While our management believes that our internal accruals and proposed Issue proceeds will be sufficient to meet our present working capital requirements, there can be no assurance that we will continue to generate adequate internal resources or obtain timely external financing in the future. Any inability to meet our working capital requirements could adversely affect our business operations, profitability, cash flows, and overall financial condition.

**6. *Dependence on Rented Premises for our Registered Office and risks arising from non-renewal or termination of such rental arrangements may adversely affect our business operations and financial condition.***

Our Registered Office is located at premises taken on rent and is not owned by the Company. Accordingly, our continued use of such premises is dependent upon the subsistence and renewal of the applicable rental arrangement.

There can be no assurance that we will be able to renew the rent agreement on favourable terms or within the required timelines. Any disruption in our access to these premises may adversely affect our business operations, financial condition, and results of operations.

**7. *Our Company has not applied for registration of any trademark or logo, and any inability to protect our brand identity may adversely affect our business.***

As on the date of this Draft Letter of Offer, our Company has not applied for registration of any trademark or logo under the applicable trademark laws in India. Consequently, our Company does not have statutory protection over its brand identity and may face risks relating to unauthorized use, imitation, or misuse by third parties.

Any infringement, misuse, or negative publicity associated with our brand name may adversely affect our reputation, goodwill, and future growth strategy. Further, in the event of any dispute or objection relating to the use of our brand name or logo, we may be required to modify or discontinue the same, which could adversely impact the goodwill and recognition associated with our business.

Additionally, any failure to adequately protect our intellectual property, confidential information, or proprietary business data may expose us to litigation, increased costs, and operational disruptions, which could adversely affect our business, financial condition, and results of operations.

**8. *Our Company does not have any insurance policy to protect us against potential losses, which could materially affect our business and financial condition.***

Our Company currently does not maintain any insurance policy in respect of its business operations, registered office, key personnel, or goods in transit. Consequently, we are exposed to various operational and business risks for which no insurance coverage is available to compensate potential losses.

Our operations may be affected by events such as accidents, theft, pilferage, spoilage, mishandling, damage or loss of goods during transit, natural calamities, fire, third-party claims or other unforeseen incidents. Any such event may result in financial losses, business interruptions, liabilities or additional expenditures that would have to be borne entirely by the Company.

In the absence of insurance coverage, any significant loss, damage or liability may have a material adverse effect on our business operations, profitability, cash flows, financial condition and results of operations.

**9. *We currently derive all our revenue from Telangana and any adverse developments affecting our operations in this region could adversely impact our revenue and results of operations.***

For the year ended March 31, 2026, the Company derived 100.00% of its revenue from customers located in Telangana. Accordingly, our business and revenue are currently concentrated in a single geographic region.

Any adverse economic, regulatory, political, agricultural, climatic or competitive developments in Telangana, including changes in market conditions, customer preferences or government policies, may adversely affect demand for our products and impact our operations. Further, our ability to reduce such concentration risk depends on successfully expanding our presence into other geographies, which may not be achieved in a timely manner or at all.

As a result, any adverse developments in Telangana could have a material adverse effect on our business, financial condition, cash flows and results of operations.

**10. Major portion of our revenue is derived from a limited number of customers. Any failure to retain customers or any disruption of sale of our product will have an adverse effect on our financial performance and results of operations.**

For the year ended March 31, 2026, the company derived 100.00% of its revenue from a single customer. As a result, our business is significantly dependent on the continued relationship with and purchase orders from such customer. Any loss of this customer, reduction in orders, or inability to acquire new customers could materially and adversely affect our business, financial condition, and results of operations. Our dependence on a single customer makes our revenues vulnerable to changes in their business, financial condition, or purchasing decisions, and there can be no assurance that we will be able to diversify our customer base in the foreseeable future.

**11. We are heavily dependent on certain suppliers for procurement and sale of our traded goods. Any disruption in supply or offtake from such entities may affect our business operations.**

For the year ended March 31, 2026, six suppliers accounted for a substantial portion of our purchases. As we operate a trading business and do not manufacture the products sold by us, our ability to fulfil customer orders is dependent on the timely availability of goods from these suppliers.

We have not entered into long-term or formal supply agreements with these key suppliers. Any interruption in supply, failure to deliver goods in required quantities, delays in delivery, increase in prices, deterioration in product quality, or financial or operational difficulties faced by such suppliers may adversely affect our ability to procure products and fulfil customer requirements.

Any disruption in our supply chain or inability to identify alternative suppliers on commercially acceptable terms may result in delays in execution of orders, loss of customers and reduced revenues, which could adversely affect our business operations, financial condition and results of operations.

**12. Our Company's ability to pay dividends in the future will depend upon our future earnings, financial condition, and cash flows. Any inability to declare a dividend may adversely affect the trading price of our Equity Shares.**

Our Company has not declared any dividends in the last five financial years and may continue to retain future earnings, if any, to support business operations, working capital requirements and growth. Accordingly, there can be no assurance that dividends will be declared or paid in the foreseeable future.

Any decision regarding the declaration and payment of dividends will be at the discretion of our Board of Directors and will depend on factors such as our financial performance, cash flows, business requirements, and applicable legal provisions, including the Companies Act, 2013. Consequently, returns to shareholders may primarily depend on any appreciation in the market price of our equity shares, and there can be no assurance that such appreciation will occur.

**13. If we are unable to source business opportunities effectively, we may not achieve our financial objectives.**

Our business growth depends on our ability to identify suitable trading opportunities in agricultural seeds, establish relationships with suppliers and customers, and efficiently manage procurement and delivery of products. As we operate a trading model, our success depends on our ability to source products at competitive prices and meet customer requirements in a timely manner.

Any inability to identify new business opportunities, expand our customer base, manage operations efficiently, or adapt to changing market conditions and strategies may adversely affect our revenue and profitability. Further, increased competition or changes in industry dynamics may limit our ability to grow our business.

Any such factors may adversely affect our business operations, financial condition, and results of operations.

**14. Our Company has not entered into any long-term contracts with our customers and any reduction, delay or cancellation of orders may adversely affect our business, financial condition and results of operations.**

Our Company generally conducts business on the basis of purchase orders received from customers and has not entered into long-term supply agreements with them. Accordingly, our customers are not obligated to place orders with us on a recurring basis and may reduce, postpone or discontinue purchases at any time.

Our revenues are dependent on continued customer demand, customer satisfaction, pricing, product availability and prevailing market conditions. Any change in customer preferences, procurement policies, inventory management practices or purchasing patterns may result in a reduction in orders.

As we do not have contractual assurances of future business from our customers, any significant reduction, delay or cancellation of orders, or our inability to maintain customer relationships and secure repeat business, may adversely affect our revenues, profitability, cash flows and results of operations.

**15. *In addition to our existing indebtedness for our operations, we may be required to obtain further loan during the course of business. There can be no assurance that we would be able to service our existing and/or additional indebtedness.***

In addition to our existing indebtedness, we may require further borrowings including working capital loans to support our business and growth plans. Increased borrowings, if any, would adversely affect our debt-equity ratio and our ability to further borrow on favourable terms in the future. Any failure to service our indebtedness or otherwise perform our obligations under our financing agreements could lead to termination of our credit facilities, trigger cross default provisions, penalties and acceleration of amounts due under such facilities which may adversely affect our liquidity, business, financial condition and results of operations.

**16. *Dependence upon transportation services for supply and transportation of our products are subject to various uncertainties and risks, and delays in delivery may result in rejection of products by customer.***

We do not have an in-house transportation facility and we rely on third party transportation and other logistic facilities for procurement of products from our suppliers and delivery of products to our customers. We generally engage such service providers on a need basis and have not entered into long-term or definitive arrangements with them.

Our operations are exposed to various transportation-related risks, including delays, accidents, theft, pilferage, mishandling, damage to goods, adverse weather conditions, labour disruptions and governmental restrictions. Any such event may result in delayed deliveries, deterioration in product quality, rejection of goods by customers, customer claims or loss of business opportunities.

Further, our Company does not maintain transit insurance for goods transported through third-party logistics providers. Accordingly, any loss, damage or liability arising during transit may not be fully recoverable and may have to be borne by the Company.

Any disruption in transportation services or loss of goods during transit could adversely affect our business operations, customer relationships, financial condition and results of operations.

**17. *Delays or defaults in customer payments could adversely affect our financial condition, cash flows, and overall business operations.***

Our business operations are significantly dependent on the timely realization of payments from our customer. We are exposed to risks relating to delays or defaults in payments, which in turn may adversely affect our liquidity, working capital cycle, and overall financial performance. The creditworthiness and financial stability of our customer are critical to our ability to collect receivables in a timely manner. Any delay in payment or default by our customers may compel us to extend additional working capital or borrowings to finance ongoing operations, thereby increasing our financing costs and affect our operational flexibility.

Although our Company has not faced any material instance of customer default in the past, there can be no assurance that all customers will continue to meet their payment obligations on time in the future. Factors such as financial instability, cash flow constraints, weak business performance, or adverse macroeconomic conditions could impair their ability to make timely payments. Any significant delay or non-recovery of dues from our customers could adversely impact our revenues, cash flows, and overall financial condition.

**18. *As a listed company, our Company is subject to certain obligations and reporting requirements under the SEBI Listing Regulations, and we must comply with other SEBI regulations as may be applicable to us.***

Our Company got listed on the BSE Platform on September 29, 1994. There was instance of non-compliance by the Company wherein it failed to submit Shareholding pattern under Regulation 31(1)(b) of SEBI (LODR) Regulations for two consecutive quarters March 2018 and June 2018. Consequently, trading in equity shares of the company was suspended from 14<sup>th</sup> May, 2019 to 30<sup>th</sup> September, 2024. The company also received a delisting order dated 12<sup>th</sup> July, 2024. Thereafter, the Company paid the applicable reinstatement fees, and the suspension of trading was subsequently revoked. These instances of non-compliance have subjected the Company to regulatory actions and may have exposed it to reputational risks and increased scrutiny by the stock exchange and other regulatory authorities.

There can be no assurance that our Company will always be able to comply with all regulatory and disclosure requirements in a timely manner in the future. Any further delay, default, or non-compliance may result in additional monetary penalties, restrictions on certain corporate actions, or other disciplinary measures by the regulators. Such actions could adversely affect our reputation, investor confidence, ability to raise capital in the future, and overall business operations. **19. Our inability to obtain, renew or maintain our statutory and regulatory permits and approvals required to operate our business may have a material adverse effect on our business, financial condition and results of operations.**

We are required to obtain, maintain, and renew various permits and approvals for our existing and proposed operations under applicable laws. There can be no assurance that such approvals will be granted or renewed within the expected timelines or at all.

Any failure to obtain, renew, or comply with the terms and conditions of these permits and approvals may result in interruptions to our operations and could materially and adversely affect our business, financial condition, and results of operations. Compliance with applicable regulations may also involve significant costs and operational restrictions. Further, any adverse interpretation by regulatory authorities or actions taken against us for non-compliance may lead to penalties and negatively impact our business.

## **RISKS RELATING TO RIGHTS ISSUE AND OBJECTS OF THE ISSUE**

**20. A Substantial Portion of the Net Proceeds from the Rights Issue is proposed to be utilized for Working Capital requirements, and any inefficient deployment or variation in these requirements may adversely affect our Liquidity, Operations, and Financial Performance**

Our Company proposes to allocate approximately ₹ 559.90 Lakhs, representing a substantial portion of the Net Proceeds from the Rights Issue, towards meeting its working capital requirements. Working capital is essential for supporting day-to-day operations, including financing inventory, trade receivables, other current assets, trade payables, and short-term financial obligations. The quantum and deployment of working capital are inherently dynamic and influenced by several factors such as business growth, operational costs, customer credit cycles, market conditions, and seasonality in demand.

Unlike investments in fixed assets, the working capital cycle is continuously revolving, and therefore, monitoring and effectively managing its utilization poses ongoing operational challenges. Any inefficiency, diversion, or delay in deployment of the working capital funds could strain our liquidity, disrupt operations, and adversely affect our cash flows and profitability. Furthermore, the actual working capital requirements may differ from current estimates due to changes in our business operations, market fluctuations, or external economic factors.

In the event of any shortfall, our Company may need to seek additional financing through borrowings or other sources, which could increase our financial costs and affect our overall financial position. The proposed utilization of the Net Proceeds is based on management’s current business plans, internal estimates, and prevailing market conditions. However, these assumptions are subject to change due to factors beyond our control, including market volatility, competitive pressures, and macroeconomic developments. Consequently, our management may, at its discretion and in accordance with applicable laws, revise or reschedule the proposed deployment of funds. Any such change could have an adverse impact on our business operations, liquidity position, and financial condition.

**21. The Rights Entitlement of Eligible Equity Shareholders holding Equity Shares in physical form may lapse in case they fail to furnish the details of their demat account to the Registrar.**

In accordance with Regulation 77A of the SEBI ICDR Regulations read with the SEBI ICDR Master Circular HO/49/14/14(2)2026-CFD-POD2/1/4518/2026 (Last updated on February 09, 2026), the credit of Rights Entitlements and Allotment of Rights Equity Shares shall be made in dematerialized form only. Prior to the Issue Opening Date, our Company shall credit the Rights Entitlements to the demat accounts of the Eligible Equity Shareholders holding the Equity Shares in dematerialised form.

Our Company has opened a separate demat suspense escrow account (namely, “OMEGA AG SEEDS PUNJAB LIMITED - UNCLAIMED SUSPENSE ESCROW ACCOUNT”) and would credit Rights Entitlements on the basis of the Equity Shares: (a) held by Eligible Equity Shareholders which are held in physical form as on Record Date; or (b) which are held in the account of the Investor Education and Protection Fund (“IEPF”) authority; or which of the Eligible Equity Shareholder whose demat accounts are frozen or where the Equity Shares are lying in the unclaimed/

suspense escrow account / demat suspense account (including those pursuant to Regulation 39 of the SEBI LODR Regulations) or details of which are unavailable with our Company or with the Registrar on the Record Date or where Equity Shares have been kept in abeyance or where entitlement certificate has been issued or where instruction has been issued for stopping issue or transfer or where letter of confirmation lying in escrow account; or (d) where credit of the Rights Entitlements have returned/reversed/failed for any reason; or (e) where ownership is currently under dispute, including any court or regulatory proceedings or where legal notices have been issued, if any or (f) such other cases where our Company is unable to credit Rights Entitlements for any other reasons.

Our Company shall credit the Rights Entitlements to the Demat Suspense Account on the basis of information available with our Company and to serve the interest of relevant Eligible Equity Shareholders to provide them with a reasonable opportunity to participate in the Issue. The credit of the Rights Entitlements to the Demat Suspense Account by our Company does not create any right in favor of the relevant Eligible Equity Shareholders for transfer of Rights Entitlement to their demat account or to receive any Equity Shares in the Issue.

With respect to the Rights Entitlements credited to the Demat Suspense Account, the Eligible Equity Shareholders are required to provide relevant details / documents as acceptable to our Company or the Registrar (such as applicable regulatory approvals, self-attested PAN and client master sheet of demat account, details/ records confirming the legal and beneficial ownership of their respective Equity Shares, etc.) to our Company or the Registrar no later than two clear Working Days prior to the Issue Closing Date to enable credit of their Rights Entitlements by way of transfer from the Demat Suspense Account to their demat account at least one day before the Issue Closing Date, to enable such Eligible Equity Shareholders to make an application in this Issue, and this communication shall serve as an intimation to such Eligible Equity Shareholders in this regard. In the event that the Eligible Equity Shareholders are not able to provide relevant details to our Company or the Registrar by the end of two clear Working Days prior to the Issue Closing Date, Rights Entitlements credited to the Demat Suspense Account shall lapse and extinguish in due course and such Eligible Equity Shareholder shall not have any claim against our Company and our Company shall not be liable to any such Eligible Equity Shareholder in any form or manner and such lapsing of Rights Entitlement may dilute and adverse impact the interest of certain Eligible Equity Shareholders. For details, please see “*Terms of the Issue*” on page 56.

- 22. *The Eligible Equity Shareholders holding Equity Shares in physical form will have no voting rights in respect of Rights Equity Shares until they provide details of their demat account and Rights Equity Shares are transferred to such demat account from the demat suspense account thereafter.***

In accordance with the SEBI ICDR Master Circular, the credit of Rights Entitlement and allotment of Equity Shares shall be made in dematerialized form only. Accordingly, the Rights Entitlements of the Physical Shareholders shall be credited in a suspense escrow demat account opened by our Company during the Issue Period. The Physical Shareholders are requested to furnish the details of their demat account to the Registrar not later than two clear Working Days prior to the Issue Closing Date to enable the credit of their Rights Entitlements in their demat accounts at least one day before the Issue Closing Date. The Rights Entitlements of the Physical Shareholders who do not furnish the details of their demat account to the Registrar not later than two clear Working Days prior to the Issue Closing Date, shall lapse. For further information, see “*Terms of the Issue*” on page 56.

- 23. *If our Company does not receive the minimum subscription of 90% of the total Issue Size, the Issue may fail.***

In the event our Company does not receive the minimum subscription of 90% of the total Issue Size or the subscription level falls below 90% of the total Issue Size after the Issue Closing Date on account of withdrawal of Applications or technical rejections or any other reason, our Company shall refund the entire subscription amount received not later than four days from the closure of the Rights Issue or any other period may be prescribed under applicable law. In the event there is a delay in making a refund of the subscription monies, our Company shall be required to pay interest for the delayed period at such a rate prescribed under applicable law. However, the risk factor is associated pertaining to rights issue is to achieve the minimum subscription by the Company from its shareholders as the allotment of shares are only in dematerialisation form by the Company and physical shares required to be converted in dematerialised form for right entitlement.

- 24. *The ex-rights price of our equity shares is indicative and is based on the prevailing market price of our equity shares.***

The ex-rights price of our equity shares is indicative and is based on the prevailing market price of our equity shares and other relevant factors. The market price of our equity shares may fluctuate due to various factors and may rise or fall following the rights issue. There can be no assurance that the market price will be sustained at or above the issue price, and investors may not be able to sell their equity shares at or above the issue price. For further information, please refer to the chapter titled “Basis/Rationale for Issue Price” beginning on page 51.

**25. *Applicants to this Issue are not allowed to withdraw their Applications after the Issue Closing Date.***

In terms of the SEBI ICDR Regulations, applicants in this Issue are not allowed to withdraw their Applications after the Issue Closing Date. The Allotment in this Issue and the credit of such Rights Equity Shares to the Applicant's demat account with its depository participant shall be completed within such period as prescribed under the applicable laws. There is no assurance, however, that material adverse changes in the international or national monetary, financial, political or economic conditions or other events in the nature of force majeure, material adverse changes in our business, results of operations or financial condition, or other events affecting the Applicant's decision to invest in the Rights Equity Shares, would not arise between the Issue Closing Date and the date of Allotment in this Issue. Occurrence of any such events after the Issue Closing Date could also impact the market price of our Equity Shares. The Applicants shall not have the right to withdraw their applications in the event of any such occurrence. We cannot assure you that the market price of our Equity Shares will not decline below the Issue Price. To the extent the market price for our Equity Shares declines below the Issue Price after the Issue Closing Date, the shareholder will be required to purchase Rights Equity Shares at a price that will be higher than the actual market price for the Equity Shares at that time. Should that occur, the shareholder will suffer an immediate unrealized loss as a result. We may complete the Allotment even if such events may limit the Applicants' ability to sell our Equity Shares after this Issue or cause the trading price of our Equity Shares to decline.

**26. *Failure to exercise or sell the Rights Entitlements will cause the Rights Entitlements to lapse without compensation and result in a dilution of shareholding.***

Rights Entitlements that are not exercised prior to the end of the Issue Closing Date will expire and become null and void, and Eligible Equity Shareholders will not receive any consideration for them. The proportionate ownership and voting interest in our Company of Eligible Equity Shareholders who fail (or are not able) to exercise their Rights Entitlements will be diluted. Even if you elect to sell your unexercised Rights Entitlements, the consideration you receive for them may not be sufficient to fully compensate you for the dilution of your percentage ownership of the equity share capital of our Company that may be caused as a result of the Issue. Renounees may not be able to apply in case of failure of completion of renunciation through off-market transfer in such a manner that the Rights Entitlements are credited to the demat account of the Renounees prior to the Issue Closing Date. Further in case, the Rights Entitlements do not get credited in time, in case of On Market Renunciation, such Renounee will not be able to apply in this Issue with respect to such Rights Entitlements. For details, see "*Terms of the Issue*" on page 56.

**27. *Our Company will not distribute the Letter of Offer and other Issue related materials to overseas shareholders who have not provided an address in India for service of documents.***

We will not distribute the Issue Material to the shareholders who have not provided an address in India for service of documents. The Issue Material will not be distributed to addresses outside India on account of restrictions that apply to circulation of such materials in various overseas jurisdictions. In the case that Eligible Equity Shareholders have provided their valid e-mail address, the Letter of Offer will be sent only to their valid e-mail address and in the case that such Eligible Equity Shareholders have not provided their e-mail address, then the Letter of Offer will be dispatched, on a reasonable effort basis, to the Indian addresses provided by them.

**28. *Overseas shareholders may not be able to participate in the Company's future rights offerings or certain other equity issues.***

If our Company offers or causes to be offered to holders of its Equity Shares rights to subscribe for additional Equity Shares or any right of any other nature, our Company will have discretion as to the procedure to be followed in making such rights available to overseas holders of the Equity Shares or in disposing of such rights for the benefit of such holders. For instance, our Company may not offer such rights to the holders of Equity Shares who have a registered address in the United States unless: (i) a registration statement is in effect, if a registration statement under the U.S. Securities Act is required in order for the Company to offer such rights to holders and sell the securities represented by such rights; or (ii) the offering and sale of such rights or the underlying securities to such holders are exempt from registration under the provisions of the U.S. Securities Act. Our Company has no obligation to prepare or file any registration statement. Accordingly, shareholders who have a registered address in the United States may be unable to participate in future rights offerings and may experience a dilution in their holdings as a result.

**29. *Investors will be subject to market risks until our Equity Shares credited to the investor's demat account are listed and permitted to trade.***

Investors can start trading the Rights Equity Shares allotted to them only after they have been credited to an investor's demat account, are listed and permitted to trade. Since our Equity Shares are currently traded on the BSE, investors will be subject to market risk from the date they pay for the Rights Equity Shares to the date when trading approval is

granted for the same. Further, there can be no assurance that the Rights Equity Shares allocated to an investor will be credited to the investor's demat account or that trading in such Equity Shares will commence in a timely manner.

**30. *Any future issuance of Equity Shares by our Company or sales of our Equity Shares by any of our Company's significant shareholders may adversely affect the trading price of our Equity Shares.***

Any future issuance of Equity Shares by us could dilute your shareholding. Any such future issuance of our Equity Shares or sales of our Equity Shares by any of our significant shareholders may also adversely affect the trading price of our Equity Shares, and could impact our ability to raise capital through an offering of our securities. We cannot assure you that we will not issue further equity shares or that the shareholders will not dispose of, pledge, or otherwise encumber their equity shares. In addition, any perception by investors that such issuances or sales might occur could also affect the trading price of our Equity Shares.

**31. *The Rights Equity Shares may experience price and volume fluctuations.***

The market price of the Rights Equity Shares can be volatile as a result of several factors beyond our control, including volatility in the Indian and global securities markets, our results of operations, the performance of our competitors, developments in the Indian finance and lending sector, changing perceptions in the market about investments in this sector in India, investor perceptions of our future performance, adverse media reports about us or our sector, changes in the estimates of our performance or recommendations by financial analysts, significant developments in India's economic liberalization and deregulation policies, and significant developments in India's fiscal regulations. In addition, the stock exchange may experience significant price and volume fluctuations, which may have a material adverse effect on the market price of the Rights Equity Shares.

General or industry specific market conditions or stock performance or domestic or international macroeconomic and geopolitical factors unrelated to our performance also affect the price of the Rights Equity Shares. In particular, the stock market as a whole recently experienced extreme price and volume fluctuations that have affected the market price of many companies in ways that may have been unrelated to the companies' operating performances. For these reasons, investors should not rely on recent trends to predict future share prices, results of operations or cash flow and financial condition.

**32. *No market for the Rights Entitlements may develop and the price of the Rights Entitlements may be volatile.***

No assurance can be given that an active trading market for the Rights Entitlements will develop on the Stock Exchange during the Renunciation Period or that there will be sufficient liquidity in Rights Entitlements trading during this period. The trading price of the Rights Entitlements will not only depend on supply and demand for the Rights Entitlements, which may be affected by factors unrelated to the trading in the Equity Shares, but also on the quoted price of the Equity Shares, amongst others. Factors affecting the volatility of the price of the Equity Shares, as described herein, may magnify the volatility of the trading price of the Rights Entitlements, and a decline in the price of the Equity Shares will have an adverse impact on the trading price of the Rights Entitlements. Since the trading of the Rights Equity Shares will be on a separate segment compared to the Equity Shares on the floor of the Stock Exchange, the trading of Rights Equity Shares may not track the trading of Equity Shares.

**33. *Foreign investors are subject to foreign investment restrictions under Indian law that limit our Company's ability to attract foreign investors, which may adversely affect the market price of the Equity Shares.***

Under the foreign exchange regulations currently in force in India, transfers of shares between non-residents and residents and issuances of shares to non-residents are freely permitted (subject to certain exceptions) if they comply with the requirements specified by the RBI. If such issuances or transfers of shares are not in compliance with such requirements or fall under any of the specified exceptions, then prior approval of the RBI will be required. We have undertaken or recorded such transactions in the past based on a bona fide interpretation of the law. We cannot assure you that our interpretation would be upheld by the Indian regulators. Any change in such interpretation could impact the ability of our Company to attract foreign investors.

In addition, shareholders who seek to convert the Indian Rupee proceeds from a sale of shares in India into foreign currency and repatriate that foreign currency from India will require a no-objection or tax clearance certificate from the income tax authority. Additionally, the Government of India may impose foreign exchange restrictions in certain emergency situations, including situations where there are sudden fluctuations in interest rates or exchange rates, where the Government of India experiences extreme difficulty in stabilizing the balance of payments, or where there are substantial disturbances in the financial and capital markets in India. These restrictions may require foreign investors to obtain the Government of India's approval before acquiring Indian securities or repatriating the interest or dividends

from those securities or the proceeds from the sale of those securities. We cannot assure you that any approval required from the RBI or any other government agency can be obtained on any particular terms, or at all.

**34. *Rights of shareholders under Indian law may differ or may be more limited than under the laws of other jurisdictions.***

The Companies Act and rules made thereunder, the rules and regulations issued by SEBI and other regulatory authorities, the Memorandum of Association, and the Articles of Association govern the corporate affairs of our Company. Indian legal principles relating to these matters and the validity of corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another jurisdiction. In accordance with the provisions of the Companies Act the voting rights of an equity shareholder in a company shall be in proportion to the share of a person in the paid-up equity share capital of that company. Further, Section 106(1) of the Companies Act states that the articles of a company may provide that no member shall exercise any voting right in respect of any shares registered in his name on which any calls or other sums presently payable by him have not been paid, or in regard to which the company has exercised any right of lien.

**35. *You may be subject to Indian taxes arising out of capital gains on the sale of the Rights Equity Shares.***

Under the current Indian Income Tax provisions, all transactions of purchase and sales of securities on Indian stock exchange are subject to levy of securities transaction tax (STT) which will be collected by respective stock exchange on which the securities are transacted. Accordingly, the Indian Income Tax Act has special capital gains tax provisions for all transactions of purchase and sale of equity shares carried out on the Indian Stock Exchange. Under the current Indian Income Tax provisions, unless specifically exempted, capital gains arising from the sale of equity shares in an Indian company are generally taxable in India.

**36. *Investors may be restricted in their ability to exercise pre-emptive rights under Indian law and thereby may suffer future dilution of their ownership position.***

Under the Companies Act, a company having share capital and incorporated in India must offer its holders of equity shares pre-emptive rights to subscribe and pay for a proportionate number of shares to maintain their existing ownership percentages before the issuance of any new equity shares, unless the pre-emptive rights have been waived by adoption of a special resolution by the company. However, if the law of the jurisdiction the investors are in, does not permit them to exercise their pre-emptive rights without our Company filing an offering document or registration statement with the applicable authority in such jurisdiction, the investors will be unable to exercise their pre-emptive rights unless our Company makes such a filing. If we elect not to file a registration statement, the new securities may be issued to a custodian, who may sell the securities for the investor's benefit. The value such custodian receives on the sale of such securities and the related transaction costs cannot be predicted. In addition, to the extent that the investors are unable to exercise pre-emptive rights granted in respect of the Equity Shares held by them, their proportional interest in our Company would be reduced.

## **EXTERNAL RISK FACTORS**

**37. *Our business, results of operations and cash flows is substantially affected by prevailing economic, political and other conditions in emerging and global markets.***

The Indian economy and securities markets are influenced by economic, political and market conditions in India and globally, including adverse geopolitical conditions. We are incorporated in India, and a substantial amount of our operations are located in India and overseas. As a result, we are highly dependent on prevailing economic conditions in India and the other emerging and global markets and our results of operations and cash flows are significantly affected by factors influencing the economy in these countries. Factors that may adversely affect the economy, and hence our results of operations and cash flows, may include:

- any increase in interest rates or inflation;
- any exchange rate fluctuations;
- any scarcity of credit or other financing, resulting in an adverse impact on economic conditions and scarcity of financing for our expansions;
- prevailing income conditions among consumers and corporates;
- volatility in, and actual or perceived trends in trading activity on, the relevant market's principal stock exchange;
- changes in tax, trade, fiscal or monetary policies;
- political instability, terrorism or military conflict in the region or globally;

- occurrence of natural or man-made disasters;
- prevailing regional or global economic conditions, including in the relevant country's principal export markets;
- any downgrading of debt rating by a domestic or international rating agency;
- instability in financial markets;
- disruption of supply chain and logistics arrangements; and
- other significant regulatory or economic developments in or affecting India or the emerging and global markets.

In addition, any slowdown or perceived slowdown in the Indian economy or the economy of any emerging and global market, or in specific sectors of such economies, could adversely impact our business, results of operations and financial condition and the price of the Equity Shares.

**38. *Inflation in India could have an adverse effect on our profitability and if significant, on our financial condition.***

Inflation rates in India have been volatile in recent years, and such volatility may continue in the future. India has experienced high inflation in the recent past. Increased inflation can contribute to an increase in interest rates and increased costs to our business, including increased costs of salaries, and other expenses relevant to our business.

High fluctuations in inflation rates may make it more difficult for us to accurately estimate or control our costs. Any increase in inflation in India can increase our expenses, which we may not be able to pass on to our customers, whether entirely or in part, and the same may adversely affect our business and financial condition. In particular, we might not be able to reduce our costs or increase our rates to pass the increase in costs on to our customers. In such case, our business, results of operations, cash flows and financial condition may be adversely affected.

**39. *Natural calamities, climate change and health epidemics and pandemics such as COVID-19 could adversely affect the economy of countries globally and our business, financial condition and results of operations. In addition, hostilities, terrorist attacks, civil unrest and other acts of violence could adversely affect our business, results of operations and financial condition.***

Several countries have experienced natural calamities, such as earthquakes and floods in recent years. Natural calamities could have an adverse impact on the global economy which, in turn, could adversely affect our business, and may damage or destroy our borrowers' assets or projects. Any of these natural calamities could adversely affect our business, results of operations and financial condition. A number of countries in Asia, including India, as well as countries in other parts of the world, are susceptible to contagious diseases and, for example, have had confirmed cases of the highly pathogenic H7N9, H5N1 and H1N1 strains of influenza in birds and swine. In addition, the COVID-19 pandemic, had caused a worldwide health crisis and economic downturn. Any future outbreak of health epidemics may restrict the level of business activity in affected areas, which may, in turn, adversely affect our business.

**40. *Changing laws, rules and regulations and legal uncertainties may adversely affect our business, prospects, results of operations and cash flows.***

Our business is subject to various central and state laws, regulations and government policies relating to the sale of agricultural inputs and seeds, taxation, labour and other commercial activities. Any changes in the applicable laws, regulations, licensing requirements or government policies, or changes in their interpretation or implementation by the relevant authorities, may require us to incur additional compliance costs, modify our business practices or obtain additional approvals. Such changes may adversely affect our business operations, financial condition, cash flows and results of operations.

We are also subject to various tax laws, including the Goods and Services Tax regime and other direct and indirect tax regulations. Any amendments to the existing tax framework, changes in tax rates, withdrawal of exemptions or incentives, or adverse interpretation of tax laws by the authorities may increase our tax liabilities, compliance burden and operating costs. In addition, any disputes relating to tax assessments or non-compliance, whether actual or alleged, may result in penalties, interest, litigation and reputational harm.

Further, the application of various Indian laws, rules and regulations, including anti-avoidance and other taxation provisions, remains subject to interpretation by the relevant authorities. Any adverse interpretation, retrospective amendment or introduction of new regulatory requirements could result in increased liabilities, denial of tax benefits, additional compliance obligations or other adverse consequences. Any such developments may have a material adverse effect on our business, financial condition, cash flows and results of operations.

**41. We are subject to regulatory, economic, social and political uncertainties and other factors beyond our control.**

We are incorporated in India and we conduct our corporate affairs and our business in India. Our Equity Shares are listed on BSE. Consequently, our business, operations, financial performance and the market price of our Equity Shares will be affected by interest rates, government policies, taxation, social and ethnic instability and other political and economic developments affecting India.

Factors that may adversely affect the Indian economy, and hence our results of operations may include:

- any exchange rate fluctuations, the imposition of currency controls and restrictions on the right to convert or repatriate currency or export assets;
- any scarcity of credit or other financing in India, resulting in an adverse effect on economic conditions in India and scarcity of financing for our expansions;
- prevailing income conditions among Indian customers and Indian corporations;
- epidemic or any other public health in India or in countries in the region or globally, including in India's various neighbouring countries;
- hostile or war like situations with the neighbouring countries;
- macroeconomic factors and central bank regulation, including in relation to interest rates movements which may in turn adversely impact our access to capital and increase our borrowing costs;
- volatility in, and actual or perceived trends in trading activity on, India's principal stock exchange;
- decline in India's foreign exchange reserves which may affect liquidity in the Indian economy;
- downgrading of India's sovereign debt rating by rating agencies; and
- difficulty in developing any necessary partnerships with local businesses on commercially acceptable terms and/or a timely basis.

**42. In the event we undertake future acquisitions, mergers or similar corporate actions, we may potentially be affected by competition law in India and any adverse application or interpretation of the Competition Act could in turn adversely affect our business, results of operations and financial condition.**

The Competition Act, 2002 ("**Competition Act**") was enacted for the purpose of preventing practices that have or are likely to have an adverse effect on competition in India and has mandated the Competition Commission of India to prevent such practices. Under the Competition Act, any arrangement, understanding or action, whether formal or informal, which causes or is likely to cause an appreciable adverse effect on competition ("**AAEC**") is void and attracts substantial penalties.

Further, any agreement among competitors which, directly or indirectly, involves determination of purchase or sale prices, limits or controls production, or shares the market by way of geographical area or number of customers in the relevant market is presumed to have an appreciable adverse effect in the relevant market in India and shall be void. The Competition Act also prohibits abuse of a dominant position by any enterprise. The Competition Commission of India (Procedure in regard to the transaction of business relating to combinations) Regulations ("**Combination Regulations**") require acquisitions of shares, voting rights, assets or control or mergers or amalgamations that cross the prescribed asset and turnover based thresholds to be mandatorily notified to, and pre-approved by, the Competition Commission of India. The Competition Act aims to, among other things, prohibit all agreements and transactions which may have an appreciable adverse effect in India. Consequently, all agreements entered into by us in future could be within the purview of the Competition Act. Further, the Competition Commission of India has extra-territorial powers and can investigate any agreements, abusive conduct or combination occurring outside of India if such agreement, conduct or combination has an appreciable adverse effect in India.

The Competition (Amendment) Act, 2023 ("**Competition Amendment Act**") was notified on April 11, 2023, which amends the Competition Act and gives the CCI additional powers to prevent practices that harm competition and the interests of consumers. These amendments include the introduction of deal value thresholds for assessing whether a merger or acquisition qualifies as a "combination", expedited merger review timelines, codification of the lowest standard of "control" and enhanced penalties for providing false information or a failure to provide material information. Such amendment to the Competition Act will result in additional costs for compliance, which in turn may adversely affect our business, results of operations, cash flows and prospect.

**43. Companies operating in India are subject to a variety of taxes and surcharges.**

Tax and other levies imposed by the central and state governments in India that affect our tax liability include central and state taxes and other levies, income tax, value added tax, turnover tax, service tax, stamp duty, tax on dividends

and other special taxes and surcharges which are introduced on a temporary or permanent basis from time to time. Moreover, the central and state tax scheme in India is extensive and subject to change from time to time. The central or state government may in the future increase the corporate income tax it imposes. Any such future increases or amendments may affect the overall tax efficiency of companies operating in India and may result in significant additional taxes becoming payable. Additional tax exposure could adversely affect our business, cash flows and results of operations.

**44. *Fluctuation of the Rupee against foreign currencies may have an adverse effect on the price of the Equity Shares.***

Any adverse movement in currency exchange rates during the time that it takes to undertake such conversion may reduce the net dividend to foreign investors. In addition, any adverse movement in currency exchange rates during a delay in repatriating outside India the proceeds from a sale of Equity Shares, for example, because of a delay in regulatory approvals that may be required for the sale of Equity Shares may reduce the proceeds received by Equity shareholders. For example, the exchange rate between the Rupee and the U.S. Dollar has fluctuated substantially in recent years and may continue to fluctuate substantially in the future, which may have an adverse effect on the trading price of our Equity Shares and returns on our Equity Shares, independent of our operating results.

**45. *Rights of shareholders under Indian laws may differ to those under the laws of other jurisdictions.***

Indian laws and legal principles related to corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another jurisdiction. Shareholders' rights under Indian law, including in relation to class actions, may not be as extensive as shareholders' rights under the laws of other countries or jurisdictions. Investors may face challenges in asserting their rights as shareholder in an Indian company than as a shareholder of an entity in another jurisdiction.

Our Company proposes to deploy the Net Proceeds towards the objects as described herein during FY 2026-27. The fund requirements, proposed deployment of funds and the intended use of the Net Proceeds set out above is based on our current business plan, internal management estimates, current circumstances of our business, prevailing market conditions and other commercial considerations. The major components of our working capital requirements will comprise of maintaining inventories, advances to suppliers and sundry debtors, as funds remain deployed in these current assets until they are realized or utilized in the normal course of business.

Based on our management estimations, and for other strategic, business and corporate purposes, we require additional working capital for our future growth requirements. Our working capital requirement has been increased from ₹ (62.41) lakhs in FY 2023-24 to ₹ 61.81 lakhs in FY 2025-26 primarily due to the commencement of business operations during FY 2025-26. During FY 2025-26, the Company recorded revenue from operations of ₹ 570.86 lakhs, resulting in an increase in its working capital requirements to support the expanded scale of operations.

Our working capital requirement is expected to be ₹ 719.33 Lakhs for FY 2026-27 based on our management estimation as per the current market demand.

Our Company proposed to utilise upto ₹ 559.90 lakhs of the Net Proceeds towards funding the working capital requirements of our Company in the ordinary course of business and the balance will be met from internal accruals and borrowings at an appropriate time as per the requirement.

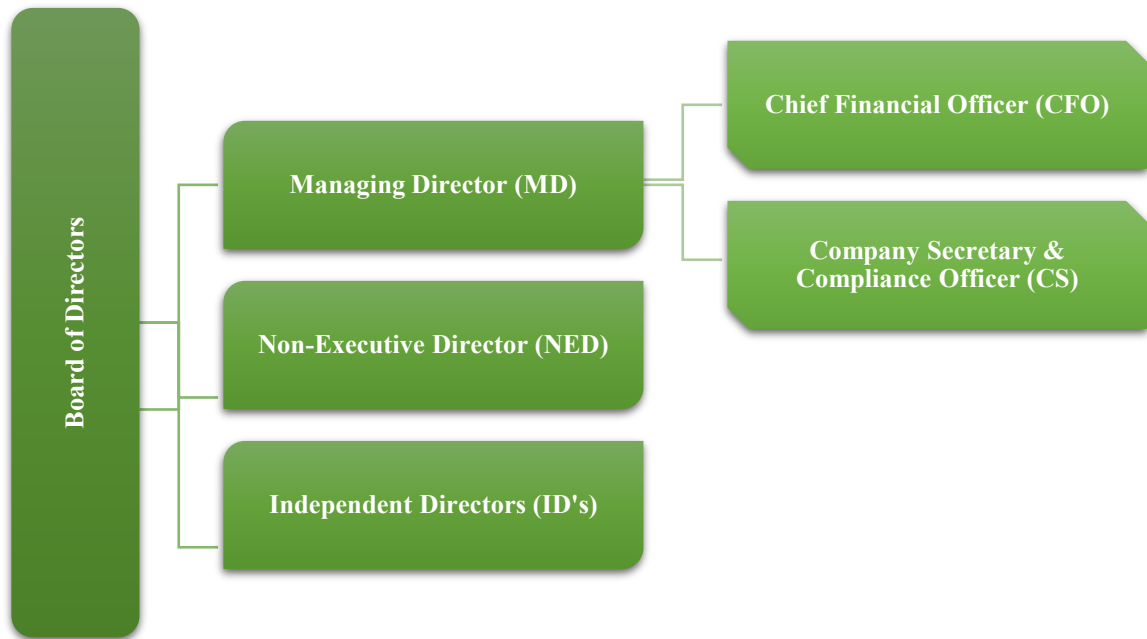

In terms of applicable FEMA Rules and the SEBI FPI Regulations, investments by FPIs in the Equity Shares is subject to certain limits, i.e., the individual holding of an FPI (including its investor group (which means multiple entities registered as foreign portfolio investors and directly and indirectly having common ownership of more than 50% of common control)) shall be below 10% of our post-Issue Equity Share capital. to the conditions as specified by SEBI and RBI in this regard. Further, the aggregate limit of all FPIs investments is up to the sectoral cap applicable to the sector in which our Company operates.

FPIs are permitted to participate in this Issue subject to compliance with conditions and restrictions which may be specified by the Government from time to time. FPIs who wish to participate in the Issue are advised to use the Application Form for non-residents. #### ***Procedure for Applications by AIFs, FVCIs, VCFs and FDI route***

The SEBI VCF Regulations and the SEBI FVCI Regulations prescribe, among other things, the investment restrictions on VCFs and FVCIs registered with SEBI. Further, the SEBI AIF Regulations prescribe, among other things, the investment restrictions on AIFs.

As per the SEBI VCF Regulations and SEBI FVCI Regulations, VCFs and FVCIs are not permitted to invest in listed companies pursuant to rights issues. Accordingly, applications by VCFs or FVCIs will not be accepted in this Issue. Further, venture capital funds registered as Category I AIFs, as defined in the SEBI AIF Regulations, are not permitted to invest in listed companies pursuant to rights issues. As per the FEMA Rules, an NRI or Overseas Citizen of India (“OCI”) may purchase or sell capital instruments of a listed Indian company on repatriation basis, on a recognised stock exchange in India, subject to the conditions, inter alia, that the total holding by any individual NRI or OCI will not exceed 5% of the total paid-up equity capital on a fully diluted basis or should not exceed 5% of the paid-up value of each series of debentures or preference shares or share warrants issued by an Indian company and the total holdings of all NRIs and OCIs put together will not exceed 10% of the total paid-up equity capital on a fully diluted basis or shall not exceed 10% of the paid-up value of each series of debentures or preference shares or share warrants. The aggregate ceiling of 10% may be raised to 24%, if a special resolution to that effect is passed by the general body of the Indian company.

Further, in accordance with press note 3 of 2020, the FDI Policy has been amended to state that all investments by entities incorporated in a country which shares land border with India or where the beneficial owner of an investment into India is situated in or is a citizen of any such country (“**Restricted Investors**”), will require prior approval of the Government of India. It is not clear from the press note whether or not an issue of the Rights Equity Shares to Restricted Investors will also require prior approval of the Government of India and each Investor should seek independent legal advice about its ability to participate in the Issue. In the event such prior approval has been obtained, the Investor shall intimate our Company and the Registrar about such approval within the Issue Period.

### ***Procedure for Applications by Mutual Funds***

A separate application can be made in respect of each scheme of an Indian mutual fund registered with SEBI and such applications shall not be treated as multiple applications. The applications made by asset management companies or custodians of a mutual fund should clearly indicate the name of the concerned scheme for which the application is being made.

No Mutual Fund scheme shall invest more than 10% of its net asset value in equity shares or equity related instruments of any single company provided that the limit of 10% shall not be applicable for investments in case of index funds or exchange traded funded or sector or industry specific schemes. No Mutual Fund under all its schemes should own more than 10% of any company's paid-up share capital carrying voting rights.

### ***Procedure for Applications by Systemically Important Non-Banking Financial Companies ("NBFC-SI")***

In case of an application made by NBFC-SI registered with RBI, (a) the certificate of registration issued by RBI under Section 45IA of RBI Act, 1934 and (b) net worth certificate from its statutory auditors or any independent chartered accountant based on the last audited financial statements is required to be attached to the application.

### ***Last date for Application***

The last date for submission of the duly filled in the Application Form or a plain paper Application is [●], i.e., Issue Closing Date. Our Board or any committee thereof may extend the said date for such period as it may determine from time to time, subject to the Issue Period not exceeding 30 days from the Issue Opening Date (inclusive of the Issue Opening Date).

If the Application Form is not submitted with an SCSB, uploaded with the Stock Exchange and the Application Money is not blocked with the SCSB, on or before the Issue Closing Date or such date as may be extended by our Board or any committee thereof, the invitation to offer contained in this Draft Letter of Offer shall be deemed to have been declined and our Board or any committee thereof shall be at liberty to dispose of the Equity Shares hereby offered, as set out in the section entitled "***Basis of Allotment***" on page 76.

### ***Withdrawal of Application***

#### **• Fractional Entitlements**

The Rights Equity Shares are being offered on a rights basis to Eligible Equity Shareholders in the ratio of [●] Equity Share for every [●] Equity Shares held on the Record Date. Where two or more persons are registered as the holders of any Equity Shares, they shall be deemed to hold the same as the joint holders with the benefit of survivorship subject to the provisions contained in our Articles of Association. In case of Equity Shares held by joint holders, the Application submitted in physical mode to the Designated Branch of the SCSBs would be required to be signed by all the joint holders (in the same order as appearing in the records of the Depository) to be considered as valid for allotment of Equity Shares offered in this Issue.

- ***Nomination***

Further, where the fraud involves an amount less than ₹ 10 Lakhs or 1% of the turnover of the company, whichever is lower, and does not involve public interest, any person guilty of such fraud shall be punishable with imprisonment for a term which may extend to five years or with fine which may extend to ₹ 50 Lakhs or with both.

## RESTRICTIONS ON FOREIGN OWNERSHIP OF INDIAN SECURITIES

There are two routes through which foreign investors may invest in India. One is the “automatic route”, where no government approval is required under Indian foreign exchange laws to make an investment as long as it is within prescribed thresholds for the relevant sector. The other route is the “government route”, where an approval is required under foreign exchange laws from the relevant industry regulator, prior to the investment.

Foreign investment in Indian securities is regulated through the Industrial Policy, 1991, of the Government of India and FEMA. While the Industrial Policy, 1991, of the Government of India, prescribes the limits and the conditions subject to which foreign investment can be made in different sectors of the Indian economy, FEMA regulates the precise manner in which such investment may be made. The Union Cabinet, as provided in the Cabinet Press Release dated May 24, 2017, has given its approval for phasing out the FIPB. Under the Industrial Policy, 1991, unless specifically restricted, foreign investment is freely permitted in all sectors of the Indian economy up to any extent and without any prior approvals, but the foreign investor is required to follow certain prescribed procedures for making such investment. Accordingly, the process for foreign direct investment (“FDI”) and approval from the Government of India will now be handled by the concerned ministries or departments, in consultation with the Department for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India (formerly known as the Department of Industrial Policy and Promotion) (“DPIIT”), Ministry of Finance, Department of Economic Affairs, FIPB section, through a memorandum dated June 5, 2017, has notified the specific ministries handling relevant sectors.

The Government has, from time to time, made policy pronouncements on FDI through press notes and press releases. The DPIIT issued the Consolidated FDI Policy Circular of 2020 (“FDI Policy”) by way of circular bearing number DPIIT file number 5(2)/2020-FDI Policy dated October 15, 2020, which with effect from October 15, 2020, consolidates and supersedes all previous press notes, press releases and clarifications on FDI issued by the DPIIT that were in force and effect as on October 15, 2020. The Government of India has from time to time made policy pronouncements on FDI through press notes and press releases which are notified by RBI as amendments to FEMA. In case of any conflict between FEMA and such policy pronouncements, FEMA prevails.

As per Rule 7 of the Foreign Exchange Management (Non-debt Instruments) Rules, 2019, the RBI has given general permission to Indian companies to issue rights securities to non-resident shareholders including additional rights securities. Further, as per the Master Direction on Foreign Investment in India dated January 4, 2018 issued by the RBI, non-residents may, inter alia, (i) subscribe for additional securities over and above their rights entitlement; (ii) renounce the securities offered to them either in full or part thereof in favour of a person named by them; or (iii) apply for the securities renounced in their favour. Applications received from NRIs and non-residents for allotment of Rights Equity Shares shall be inter alia, subject to the conditions imposed from time to time by the RBI under the FEMA in the matter of refund of Application Money, Allotment of Rights Equity Shares and issue of Allotment advice.
