POLICY FOR DETERMINATION OF MATERIALITY OF EVENTS OR INFORMATION

Legal Framework

This Policy for Determination of Materiality of Events or Information is aimed at providing guidelines to the Management of M/s Omega AG-Seeds (Punjab) Limited, to determine the materiality of events or information, which could affect investment decisions and ensure timely and adequate dissemination of information to the Stock Exchange(s) (as hereinafter defined) and public at large.

This Policy has been formulated in accordance with the guidelines laid down by Securities Exchange Board of India under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 with respect to disclosure of events and information.

Pursuant to the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Board of Directors approved the "Policy for Determination of Materiality of Events or Information" the Board shall review, and if found required, may amend this Policy from time to time.

This Policy will be applicable to the Company with effect from August 9, 2016.

Objective

The Objective of this Policy is to serve as a Guiding Charter to the Management to ensure that timely and adequate disclosure of events or information are made to the investor community by the Company under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, to enable them to take well informed investment decisions with regard to the Securities of the Company.

The Policy is framed for the purpose of Systematic Identification, Categorization, Review, Disclosure and Updating of website, the details of information / events which are considered material or not but which may have a bearing on the performance of the Company and which may materially affect the Share Price of the Company.

Introduction

All the Words and expressions used in this Policy, unless defined hereinafter, shall have meaning respectively assigned to them under the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in the absence of its definition or explanation therein, as per the Companies Act, 2013 and the Rules, Notifications and Circulars issued thereunder, as amended from time to time.

“Act” means the Companies Act, 2013 (and the Rules) and the Companies Act, 1956 to the extent applicable.

“Board of Directors” means the Board of Directors of the Company.

“Company” means Omega AG-Seeds (Punjab) Limited.

“Key Managerial Personnel” means Key Managerial Personnel as defined under Sub-section (51) of Section 2 of the Companies Act, 2013.

“Listing Regulations” or “Regulations” means the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

“Policy” means this Policy, as amended from time to time.

“SEBI” means the Securities and Exchange Board of India.

“Rules” means the rules made under the Companies Act, 2013.

Events which are deemed to be Material Events

The Company shall disclose all such events which are specified in Part A of this Policy without any application of the Guidelines for Materiality as provided in Sub-Regulation (4) of Regulation 30 of the Listing Regulations.

The Company shall first disclose to the Stock Exchange(s) of all events, as specified in Part A of this Policy, or information as soon as reasonably possible and not later than twenty-four hours from the occurrence of event or information. Provided that in case the disclosure is made after twenty-four hours of occurrence of the event or information, the Company shall, along with such disclosures provide explanation for delay. with respect to events specified in sub-para 4 Part A of this Policy shall be made within thirty minutes of the conclusion of the Board Meeting.

The Company shall, with respect to disclosures referred to in this Regulation, make disclosures updating material developments on a regular basis, till such time the event is resolved, with relevant explanations.

The Company shall disclose on its website all such events or information which has been disclosed to the Stock Exchange(s) under this Regulation, and such disclosures shall be hosted on the website of the Company for a minimum period of five years and thereafter as per the Archival Policy of the Listed Entity, as disclosed on its website. The Company shall disclose all events or information with respect to Subsidiaries which are material for the Listed Entity.

The Listed Entity shall promptly inform the Stock Exchange(s) of all information having bearing on the performance of the Listed Entity, Price Sensitive Information or any action that shall affect payment of Interest or Dividend of Non – Convertible Preference Shares or Redemption of Non – Convertible Debt Securities or Redeemable Preference Shares.

Events which are dependent on application of Guidelines for Materiality

The Company shall disclose all such Material Events pertaining to itself or its Subsidiary(ies), specified in Part B of this Policy subject to application of Guidelines for Materiality.

Guidelines for Determining Materiality

- the omission of an event or information, which is likely to result in discontinuity or alteration of event or information already available publicly; or
- the omission of an event or information is likely to result in significant market reaction if the said omission came to light, at a later date; or
- any other event / information may be treated as being material, if in the opinion of the Board of Directors of Company, the event / information is considered material.

Any other Information / Event

The Company shall disclose major developments that are likely to affect business, that may have a significant impact on the accounts, etc. and brief details thereof and any other information which is exclusively known to the Company which may be necessary to enable the holders of securities of the Company to appraise its position and to avoid the establishment of a false market in such securities.

1. GUIDANCE ON WHEN AN EVENT/ INFORMATION IS DEEMED TO BE OCCURRED

- a) The events/ information shall be said to have occurred upon receipt of approval of Board of Directors e.g. further issue of capital by rights issuance and in certain events/ information after receipt of approval of both i.e. Board of Directors and Shareholders;
- b) The events/ information that may be of price sensitive nature such as declaration of dividends etc., on receipt of approval of the event by the Board of Directors, pending Shareholder's approval;
- c) In the events/ information such as natural calamities, disruption etc. can be said to have occurred when the Company becomes aware of the events/ information, or as soon as, an officer of the entity has, or ought to have reasonably come into possession of the information in the course of the performance of his duties;

Authorize Key Managerial Personnel for the purpose of Determining Materiality of an Event or Information and for the purpose of making disclosures to the Stock Exchange

The following KMPs are hereby severally authorized by the Board of Directors for the purpose of determining materiality of an event or information and for the purpose of making disclosures to the Stock Exchange(s) ("**Authorized Person(s)**") and to suo-moto clarify / deny any report event or information, which has been made public by any means including but not limited to electronic means. They are further authorised to respond to the rumors amongst the general public, if such response will protect the interests of the Company. Such action taken by the KMPs shall however, be brought to the attention of the Board of Directors at its immediately subsequent meeting;

In the event of any conflict between the provisions of this Policy and the Companies Act, 2013 or the Listing Regulations or any other statutory enactments or Rules, the provisions of Companies Act, 2013 / Listing Regulations or Statutory Enactments, Rules shall prevail over this Policy and the part(s) so repugnant shall be deemed to severed from the Policy and the rest of the Policy shall remain in force.
